Grounds Committee Report

May 15, 2013 Submitted by Roy Benner, Chairman 5/9/13 to Barbara Morgan Accomplished:

- 1. Grass cut.
- 2. Fire Department had to cut the driveway gate lock on Sunday (4/28/13) to fight a brush fire at night.
- 3. I contacted the Cape Fire Department and the Fire Marshal on how to eliminate this in the future. The Fire Marshall's Office sent me information on and "Authorization" to purchase a "Knox Padlock" that all the Anne Arundel Fire Companies would have a key to, which would speed access to our site and eliminate them having to again cut the lock in the future. The Padlock cost \$85.00 and is an exterior all weather condition lock. See www.knoxbox.com model #3770.
- 4. I spoke with Wolford Well and Pump Services, Inc. of Pasadena, Maryland. Specifically Robert Copsey, who was drilling a well on River Bar Road, to get an estimate for a new well at Goshen Farm, when needed. He indicated, since the House was at elevation of approximately 80 feet above sea level, he (and AA County) would require the well to be drilled to the 275 foot depth aquifer. He estimated the cost at \$6,500.00. I thought it would

be good to have this figure in mind as we proceed on the remodel of the Farm House. This is just food for thought, at this time.

5. The Gravely Mower is being repaired at Annapolis Lawn and Garden, their Huntington, Maryland shop.

Needs Accomplishing:

- 1. Short Term:
 - a. Remove two downed cherry trees in the lower field that fell as a result of the "Derecho" on June 29th.
- 2. Develop a planting Master Plan reflecting 1700 landscaping for the immediate area around the Farm House.
- 3. Long Term:
 - a. Large tree near the Servant's Quarter's, Site #8, should be removed at some point. (If it falls, the roots will destroy the Servant's Quarters). Removal also of another large vine-covered tree located to the south west side of the Sharing Garden. Both should be removed for safety reasons.
 - b. The maple tree, at the south east corner of the Farm House, has a large branch overhanging the house, which should be removed. The large branch cable system is no longer affording any protection to the Farm House.
 - c. Construct a brick patio for sitting within the entrance of the Sharing Garden. Bricks are being gathered.
 - d. Develop a master plan for the grounds (trees, open areas, parking, paths, perennial gardens, Sharing Garden, other areas of use, and maintenance of the foregoing).
 - e. Develop plan to attack and control rampant growth of vines that strangle growing trees.
 - f. Use goats to clear three small areas of rampant vines. The goats will be free (friend of Becky's).
 - i. The following areas I am considering for possible 'goat' clearing of the undergrowth:
 - 1. Area around the "spring"/pond to open this area as seen in historic photographs.
 - 2. Area where original barn and silo once stood, to show footprint of the old barn.
 - 3. Area just north of Sharing Garden and slightly behind and north of Servant's Quarters for possible future expansion of the Sharing Garden, when additional water is available to the Sharing Garden.

<u>Need Approval</u>: Purchase of a Knox Padlock – cost \$85.00. <u>New Business:</u> None suggested at this time.
