#### ACTIVITIES/ACCOMPLISHMENTS

Had the poster for the Open House printed and placed them at the CSC and Bay Hills Shopping Centers businesses and dropped one off at BB&T.

Continued to work with Color Fire on revamping the web site. Due to major problems with Word Press software, they are rebuilding the entire web site according to John Maggio. I have continued to write articles and edit pictures of events and will send them to Color Fire when the web site is ready. # BUILDING COMMITTEE REPORT October 2015

In mid-August, Roy, Terry, Michael Buchet, and I met with Michael Dowling, the architect specializing in historic restorations and recommended by Jane Cox. He wrote Jane the following in an email a cc'd Goshen Farm.

The immediate issue is the failure of the floor framing and foundation support along the wall between the original building and the addition.

The existing floor system needs to be jacked up and temporarily supported while the existing wooden sill is replaced in kind, and the supporting foundation repaired. The joists (and supplemental joists - see below) can then be reseated on this new sill.

The center joist support beam needs to be examined for integrity.

A secondary issue is the floor framing itself. From a quickly (no analysis) the joists look sound the problem is mostly in the condition of the bearing sill and foundation. My suggestion would be to supplement the existing joists which are at approximately 24" centers, with new 1 3/4 X 9 1/4 LVL joists in between the existing. These could be notched to bear on the new and replacement sills.

The plate bearing the second floor joists in the front wall should be replaced in kind.

The second floor joists could then be supplemented with additional LVL joists ripped to the same depth as the existing, centered between the existing.

These are just some quick outline points, additional investigation would be required.

After a reminder email in late September, he responded with the following recommended contractors on October 2, 2015. I have not had an opportunity to contact them. Will try to schedule a visit in early November.

#### **Accomplished:**

- 1. Cut Goshen's grass two times this month.
- Received two trucks of young trees (fruit and white oaks) from two nurseries and one truck load of mulch from Bowen's for use by the Stream Restoration Grant project Students. Hillary Catan was the project leader for this partnership project.
- 3. The Goshen Farm Orchard with its 28 trees and the 25 white oak trees of the Memorial Grove were planted on September 29 by the students from Broadneck and Southern High Schools.
- 4. Had two additional loads of wood chips delivered to Goshen Farm by Richard's Tree Care for use around our gardens and pathways.
- 5. Led eight to ten AACC students on a tour of Goshen Farm. They were an English Language Learning class led by Kathryn Waterman.
- 6. New wood chips were spread on all the Sharing Garden paths, in, and leading up to the High Tunnel.
- 7. The Henson Hall Slave Garden is complete (by BB&T employees). It is now GFPS responsibility to weed this area and water the plants.
- 8. Eagle Scout Projects that are coordinated under the Ground's Chair:
  - a. Lyle Wallace, completed his Eagle Scout project of beehives, and has four hives. He constructed a picket fence around the hives but did not intentional construct a fence along the wooded side (north side) of this area. Gr5ounds Chair constructed a 3 foot gate and installed it completing the fence protection for the four hives. A latch or locking mechanism is still needed. Lyle has done an amazing amount of work on this project. He will continue to manage the hives until the spring of 2016. He is working with Jenni Biondi who will take over management of the hives next spring.
  - b. Tony Tuckfield has not been heard from since June 13 to try to clarify possible projects.
  - c. Leo Brown has not communicated his intentions concerning his Eagle Scout project.
  - d. Scout Marsh has submitted his project for pathway improvements on the path at the western side of Goshen property and is awaiting approval from the Boy Scouts of America.
  - e. Scout McGhee and his father were presented with a list of possible projects at Goshen Farm for his Eagle Scout Project.
- 9. The "Cotton Patch" planted in the lower field by Kara Maddox is doing fine, and the cotton is looking great. Please take a look at possibily the only cotton growing in the State of Maryland.
- 10. Updated the Ground's Goshen Farm PowerPoint for 2015 adding new 2015 pictures. The PowerPoint was played at the Harvest Dinner.
- 11. Laminated many signs and pictures for the Open House
- 12. Signs promoting the Goshen Farm Open House were lettered and installed along Cape St. Claire Road and also on the Green Holly Drive.
- 13. Removal of the large, decayed Silver Maple on the southwest corner of the Goshen Farm House's 1967 addition took place on October 12th, after the Open House was over. Richard's Tree Care was the low bidder and provided GFPS with the most options.
- 14. Purchased a new Ford Tractor for use on the Farm. Originally from Ohio, it was delivered on October 8<sup>th</sup>. The tractor included a brush hog and a scraper blade. The blade will be used on the driveway and for future snow removal.
- 15. Rose Mary's brother, Bob, from Ohio spent some time with the tractor on improving the driveway. It is the best the driveway has looked in years.

- 16. Asked the Anne Arundel Soil Conservation District for a survey of the gradient of the driveway to determine the best place(s) to turn out the drainage water into the woods. The AASCD is currently without an engineer so this task has been given low priority.
- 17. Doug McClelland diagnosed, ordered, and installed a new PTO clutch on the Gravely Mower. Thanks, Doug!
- 18. I would like to thank several members that helped prepare the house and grounds for the Open House: Fran Bents, Linda Beck, Jeanne Klingler, Dan Perry, and especially Dave McCormick who hauled woodchips for two consecutive days. Terry and Becky also need to be recognized for their additional help. THANKS!
- 19. Helped Becky edged the hydrangeas beds and mulched with wood chips for the Open House.
- 20. Wire brushed, cleaned, and painted the old (windmill?) well pump for display at the Open House.
- 21. E Harwood photographed the Open House. Made a copy for GFPS and Lou Biondi.
- 22. The previously installed a security camera at the Caretaker's Cottage. It was removed on October 16<sup>th</sup>.
- 23. Meet with Lisa Womeldorf and Loretta of "The Enclave Training Program" (Division of the Special Education) about conducting Special Ed classes at Goshen Farm three days a week (Tuesday, Wednesday, and Thursday) and classes would run from 11:30 AM to 1:15 PM for 18 weeks. Lou Biondi, Terry Brandon and Rich Burger also were in attendance.

### **Needs Accomplishing:**

- 1. Need to help Terry Brandon, Garden Chair, install a series of valves on the High Tunnel Drip Irrigation System. This will allow individual rows to be watered (as needed) separately, rather than watering all the plant rows at the same time.
- 2. Need to monitor the security lighting at the Farm House.
- 3. Contact Congressmen Wayne Gilchrest, Sassafras Environmental Educational Center, located at Knocks Folly in Kennedyville, Maryland, regarding his educational lesson plans and experiences in Kent County.
- 4. Long Term:
  - a. Consider expanding our single lane driveway into a two-way drive or other option(s). This action would allow Goshen Farm to expand future activities at Goshen Farm, relieve traffic issues, and ensure driveway safety.
  - b. Develop a plan to attack to control rampant growth on trees (invasive vines that strangle our growing trees).
  - c. Continue descriptions of planned activities listed in the Grounds Master Use Plan and continue layout of the grounds.
  - d. Pursue purchasing new water well for Goshen Farm or try to tie into county water system near Goshen Farm and the Cape St. Claire Elementary School.
  - e. Pursue composting toilets, holding tank(s) with pump outs, regular toilets connected to a septic system, or connecting to the county sewer system. Jim Morrison pointed out that after their research into toilet facilities, Handcock's Resolution will be **using a large holding tank** for the bathroom effluent. He states this is a **MUCH cheaper** way to handle toilet facilities in today's world.
