Goshen Farm Sharing Garden Committee Report for September 2015

Accomplished:

- 1. More gardeners have come to clean up their plots as the weather has cooled, but much needs to be done.
- 2. Sharing Garden Harvest Dinner plans will soon come to fruition under Terry Brandon's direction.
- 3. Diane and I weeded the entire foot path within the garden and I partially weeded the outside of our end of the garden.
- 4. Activity is picking up in the Sharing Garden and common areas well maintained.

Needs Accomplishing:

- 1. Short Term:
 - a. Recruit community groups for classes and work projects, i.e., the Hügelkultur.
 - b. Increase numbers of volunteers working on gardens beyond the Sharing Garden.
- 2. Long Term:
 - a. Have the garden become compost self sufficient.
 - b. Establish Goshen Farm Garden subcommittees to work on various Grounds or Garden projects.
 - c. Establish working set of relationships with local education institutions to utilize Goshen Farm grounds and Garden resources—preschool through graduate school levels as described in GFPS Business Plan.

Accomplished:

- 1. Cut Goshen's grass two times this month.
- 2. Becky and I eliminated a large brush pile of vines (cleared from the MAG Spring 2015 Pond clearing exercise. We ran all the vines through a wood chipper, belonging to Rose Mary Stocker, greatly reducing the volume.
- 3. Staked out tree locations for the 28 trees of the Goshen Farm Orchard and the 25 white oak trees of the Memorial Grove, in their respective areas. These areas will be planted on September 29th by students from Broadneck and Southern High Schools.
- 4. Cut down a large, dead locus tree, with its hundreds of vines, on the edge of the Orchard area clearing, to prevent its eventual fall onto the Goshen Farm Orchard later, damaging the orchard trees.
- 5. Had a load of wood chips delivered to the Farm by Richard's Tree Care for use around our gardens and paths.
- 6. One maintenance problem arose concerning the Gravely mower. A belt broke on the mower deck which was replaced.
- The Henson Hall Slave Garden has been completed by BB&T employees, including the two new picnic tables as part of their total donation to the Henson – Hall Slave Garden. Thank you again – BB&T Arnold Bank!
- 8. Eagle Scout Projects that are coordinated under the Ground's Chair:
 - a. Lyle Wallace, working on his Eagle Scout project, has a total of four hives at this time.
 - b. Tony Tuckfield has not been heard from since June 13 to try to clarify possible projects.
 - c. Leo Brown has not communicated his intentions concerning his Eagle Scout project.
- 9. Danny Tester and I installed 5 bluebird houses built and decorated by Brownie Troop #10465.
- 10. The "**Cotton Patch**" planted in the lower field by Kara Maddox is doing fine, and the cotton is looking great.
- 11. Updated the Ground's Goshen Farm PowerPoint for 2015 adding new 2015 pictures. Available to use this at the Harvest Dinner. I do not have a projector.
- 12. Removal of the large, decayed Silver Maple on the southwest corner of the Goshen Farm House's 1967 addition will take place on October 12, after the Open House is over. Richard's Tree Care was the low bidder, and provided GFPS with the most options.
- 13. Purchased a load of crusher run stone for use on the driveway. Stan Synowczynski continued to move much of this stone to fill existing gullies on the driveway.
- 14. Meet with the NRCS's State Engineer and others for advice and options for solving the driveway erosional problem.
- 15. Asked the Anne Arundel Soil Conservation District for a survey of the gradient of the driveway to determine the best place(s) to turn out the drainage water into the woods. I have not heard back in response to my follow-up telephone calls.
- 16. The recently constructed "teepee" was planted with what was thought to be wisteria plants but it turned out to be a unknown weed (NOT wisteria). Will now re-plant the teepee base with wisteria plants. Beans previously planted grew well on the teepee, but most of the planted squash succumbed to insects. Next year, gourds should be considered.
- 17. Signs promoting the Goshen Farm Harvest Dinner were lettered and installed along Cape St. Claire Road and on the Green Holly Drive island.
- 18. The Improvement Association's signboard, near Graul's, was rented to promote the Harvest Dinner.

- 19. Considerable time spent looking at several different tractors for Goshen Farm. Doug McCelland. also spent considerable time and effort researching and searching for an appropriate tractor. The final decision was put on a temporary hold pending the BOD President's return.
- 20. Put together a list of possible MAG Projects for a fall "2015 Work Day at the Farm". Specifics (date, projects, number of midshipmen) to be determined at the MAG group meeting, Thursday, September 17th.

Needs Accomplishing:

- 1. Need to help Terry install a series of valves on the High Tunnel Drip Irrigation System. This will allow individual rows to be watered (as needed) separately, rather than watering all the plant rows as unit.
- 2. Need to work on the driveway design with the help of the MAG volunteers.
- 3. Need to correct security lighting at the Farm House. The light on the northeast corner seems to be set incorrectly. (It is currently "on" constantly during darkness). Need to check the settings on the back of this unit.
- 4. Contact Congressmen Wayne Gilchrest, Sassafras Environmental Educational Center, located at Knocks Folly in Kennedyville, Maryland, regarding his educational lesson plans and experiences in Kent County.
- 5. Long Term:
 - a. Consider expanding our single lane driveway into a two-way drive or other option(s). This action would allow Goshen Farm to expand future activities at Goshen Farm, relieve traffic issues, and ensure driveway safety.
 - b. Develop a plan to attack to control rampant growth on trees (invasive vines that strangle our growing trees).
 - c. Continue descriptions of planned activities listed in the Grounds Master Use Plan and continue layout of the grounds.
 - d. Pursue purchasing new water well for Goshen Farm or try to tie into county water system near Goshen Farm and the Cape St. Claire Elementary School.
 - e. Pursue composting toilets, holding tank(s) with pump outs, regular toilets connected to a septic system, or connecting to the county sewer system. Jim Morrison pointed out that after their research into toilet facilities, Handcock's Resolution will be **using a large holding tank** for the bathroom effluent. He states this is a **MUCH cheaper** way to handle toilet facilities in today's world.

- 1. Security Camera(s) should become a high priority.
- 2. Girl Scout Rosner would like to present a proposal to the Board, for her Silver Award using some kind of diorama(s) placed around the GFPS property.
